Wilderness Referral Reward – Terms and Conditions

1. Eligibility:

- The referrer must be an existing guest – someone who has travelled and booked at least one trip directly with Wilderness.
- The referred individual (referred) must be new to Wilderness, having not travelled or booked with Wilderness before.

2. Referral Bonus:

- The referrer will receive a USD 1,000 credit towards their next Wilderness booking on confirmation that the referred party has paid their booking in full.
- The referred booking must exceed the value of USD 1,000.

3. Usage of Credit:

- The USD 1,000 referral credit is only applicable for use on a referrer's future Wilderness trip, booked with Wilderness directly, and does not include an existing client booking.
- A future booking made by the referrer must exceed USD 1,000 in value for the credit to be valid.
- The referral credit is non-transferable, non-exchangeable, and cannot be redeemed for cash.

4. Validity:

- The referral credit is valid for up to two years from the date that the referred travellers complete their safari.
- If the credit is not used within this two-year period, the credit will expire, and cannot be claimed or extended.

5. Booking Conditions:

- Both the referrer and the referred bookings must be booked directly through Wilderness.
- The referred must mention the referrer's details at the time of booking to be eligible for the referral credit.
