#### **AIRLINES**

**Etihad Airways** will from 15 December 2025 double its weekly flights to Nairobi from 7 to 14.

**Kenya Airways** has announced a strategic codeshare agreement with Safarilink Aviation, expanding domestic connectivity to nine key destinations. According to the airlines, the partnership will offer "seamless travel" by linking the Kenya Airways global network with Safarilink's domestic reach. Under the new agreement, Kenya Airways passengers can book single-ticket itineraries connecting international flights with Safarilink-operated routes to Amboseli, Masai Mara, Nanyuki, Loisaba, Samburu, Lewa Downs, Tsavo, Naivasha, and Diani Beach.

**RwandAir** will from 15 June 2025 increase its Johannesburg to Kigali flights from 7 to 11 flights per week. The airline currently operates a daily return flight on the route.

**Grumeti Air** will be gradually phasing out their scheduled flight service to Kigali, Rwanda to focus on where demand is higher in other areas. All confirmed bookings will be honoured, and the airline is still accepting new bookings for flights on dates where commitments have already been made. The Kigali operations will continue until the end of the peak season, concluding in late October 2025.

#### **SEYCHELLES**

# Passenger Grouping:

Guests traveling to Londolozi and Mala Mala will be grouped together for flight-planning purposes.

- Departure from OR Tambo (JNB): 11:30 → Arrival: 12:30;
- Return Departure: 12:45 → Arrival at OR Tambo: 13:45.

# Transfer Times to Lodges:

- Londolozi: Approximately 5 minutes;
- Mala Mala: Approximately 10–15 minutes.

#### Additional Services:

Lodge hops and flights to/from Kruger Mpumalanga International Airport (KMIA) will continue as scheduled, utilising their respective independent airstrips.

# **Rwanda 3% Tourism Levy**

#### The Retreat

- New bookings with no payment made and traveling from 1 July 2025 onward will be subject to the 3% tourism tax.
- The 3% Tourism Levy will apply to all existing bookings, even if a deposit has already been paid.
- Fully paid bookings settled before 1 July 2025 will not be affected by the new levy.

# **The Bishops House**

- New bookings with no payment made and traveling from 1 July 2025 onward will be subject to the 3% tourism tax.
- The 3% Tourism Levy will apply to all existing bookings, even if a deposit has already been paid.
- Fully paid bookings settled before 1 July 2025 will not be affected by the new levy.

# **Kigali Marriot Hotel**

- Bookings with deposits already paid:
  - If a deposit was made before the levy came into effect (01 July 2025), the 3% Tourism Levy will still be applied to that booking.
- Bookings with outstanding final balance:
  - If a deposit was made prior to the implementation, but the final balance remains unpaid, the 3% levy will be applied to the entire booking amount.
- Bookings with no payment made:
  - For bookings with no payment received, the levy will be applied in full, in accordance with the updated government guidelines.

#### **One&Only Rwanda**

- New bookings with no payment made and traveling from 1 July 2025 onward will be subject to the 3% tourism tax.
- For existing bookings where a deposit has been paid but a balance is still outstanding, the 3% levy will apply only to the remaining balance.
- Fully paid bookings settled before 1 July 2025 will not be affected by the new levy.

# Singita Kwitonda

The Tourism Levy is charged as 2.5% of the applicable accommodation rate. The RDB requires that the 3% levy is charged on the accommodation revenue excluding VAT. Singita's accommodation rates are inclusive of VAT so the Tourism Levy is reflected and charged as 2.5%.

# 2025 Bookings:

• The 3% Tourism Levy will only be applicable to new bookings travelling 01 July – 31 December 2025). Existing bookings will not be adjusted to include the new levy.

#### 2026 Bookings:

The 3% Tourism Levy is only applicable to new bookings made after the 2026 rates were released
(April). Existing bookings that were made prior to April before rates were released will not be adjusted to
reflect the new levy. The Tourism Levy is already loaded on the 2026 rates (since April) and costed
accordingly.



# **Volcanoes Safaris - Virunga Lodge**

- New bookings with no payment made and travel from 1 July 2025 onward will be subject to the 3% tourism levy.
- Bookings with deposits paid before 1 July 2025 will <u>not incur</u> the levy. Fully paid bookings settled prior to 1 July 2025 will also <u>not be affected</u> by the new tax.
