# Namibia Visa Fees - Effective 01 April 2025

The Namibian Ministry of Home Affairs will be implementing the following visa fees, per the new visa regulations that will take effect from 1 April 2025:

African Union (AU) countries: NAD1,200 per person

• Other countries: NAD1,600 per person



Please note there are rate changes to our helicopter flights to/from Mokete below. Your Travel Designer will update your bookings and adjust the pricing accordingly.

- Helicopter flight rates between Mokete and the Okavango, Linyanti and Maun airport, have increased.
- Helicopter flight rates between Santawani Airstrip to/from Mokete have decreased, and the minimum 2-guest requirement has been waived.

All existing provisional and confirmed bookings will be honoured at the previous rates.

#### **Governors' Aviation Minimum Passenger Requirements**

Please note the **minimum pax requirements** for Governors' Aviation scheduled regional flights:

- All Mara flights operate with a minimum of 2 passengers in the High, Mid and Low seasons.
- All Laikipia flights operate with a minimum of 2 passengers in High season and a minimum of 4 passengers in Mid and Low seasons.

#### **SEASONS:**

High Season is 01 July to 31 October and 15 December to 31 December.

Low and Mid-season is 01 January to 30 June and 01 November to 15 December.
